# Lost minutes Cost lives

Michigan needs a fully-funded statewide trauma system to save lives following life-threatening injuries

Michigan is one of only two states that does not have a fully funded statewide trauma system, which means some trauma victims will not get the critical care they require for survival.

Many patients lose their lives when life-threatening injuries are not treated at an appropriate-level trauma center.

In 2012, a young man from Pennsylvania was accidentally shot while hunting in Michigan. He had signs of life when he arrived at the hospital but had suffered considerable blood loss from uncontrolled bleeding. Because destination protocols were not in place to guide paramedics to an appropriate facility, too much time passed and the trauma team was unable to save him. Doctors told the family his injuries would have been survivable, if he had received the right life-saving treatment at each stage following the accident. He should have been transported to an appropriate trauma center with full surgical capabilities. A fully developed, all-inclusive trauma system with protocols, guidelines and continuing education saves lives.

The goal of an inclusive trauma system is to match the needs of injured patients to the appropriate trauma care facility, so that every patient receives optimal care from the initial recognition of the injury through return to the community.

underfunded trauma system risks lives



More than 5,000 trauma-related deaths occur in Michigan each year

- Trauma patients treated at trauma centers have an overall 25 percent lower risk of death. About 35 percent of trauma victims die due to a lack of access to trauma care.
- Trauma is the fourth leading cause of death in the U.S. for all ages combined.
- Falls are the top causes of traumatic deaths (41 percent) followed by motor vehicle crashes (28 percent).
- More than 1,100 of annual trauma deaths occur on Michigan's roadways.
